

Guideline about Reading the Registration of Overseas Voters

This is the guideline of the 20th General Election of National Assembly on April 13, 2016 under the ‘Law of Public Official Election’ on the reading of overseas voters’ list in Article 40 Clause 3 and Article 218 Clause 10-1 and about filing an appeal, application of dissatisfaction or registration in Article 218 Clause 11. Please check if your overseas voting right is properly registered.

I. Reading Overseas Voter’ s Registration

1. Period of reading

March 5-9, 2016 (5 days)

2. Hours for reading

○ To read the registration document of overseas voters or on PC for reading the registration record at the diplomatic office: During normal office hours of the diplomatic office

○ To read online: Anytime

3. Scope of reading

- Registration document of overseas voters kept at the diplomatic office: Overseas voters' registration residing in the jurisdiction area of the diplomatic office, and the voters registered in report of overseas absentee.
- PC at the diplomatic office for reading registration: Registration of overseas voters, and every voter registered in the overseas absentee record.
- Website: If the voter oneself is registered in the registration of overseas voters' s list.

4. Website address: ok.nec.go.kr

II. Application of appeal on the registration of overseas voters

1. Period of applying for appeal

March 5-9, 2016

2. Applicant of appeal

- Apply on the website
 - Overseas voter: About the registration of overseas voters on the website of the Central Election Management Committee (ok.nec.go.kr).
 - Overseas absentee: About the registration of overseas absentee report in the city or town on the relevant website.
- Verbal or written application at the diplomatic office
 - Use the registration document of overseas voters or the PC for reading the registration at the diplomatic office about the registration of overseas voters.
 - ※ Fill out the document of appeal at the diplomatic office and submit to the Central Election Management Committee or the head of city or town who has the right of writing registration.
- written application of appeal (no limit on the form of document) to the writer of registration shall be delivered before the deadline of appeal.

III. Application of dissatisfaction on the overseas absentee report

1. Application period: By the next day after you receive a “No reason” notification about the application of appeal on the overseas absentee report from the head of city or town.
2. Applicant: Applicant of the appeal or related person
3. How to apply: To the Election Management Committee in the city or town by writing (if residing in overseas: Send a fax)
 - ※ The method of applying for dissatisfaction and the fax number of election management office are sent to the applicant when the head of city or town notifies the result of review on the appeal application.
 - ※ If a person residing in overseas applies for dissatisfaction at the nearby diplomatic office, the manager of overseas voting sends a fax to the head of city or town.

IV. Application of registering about omissions in the list

1. Application period: The day before the confirmation date of registration of overseas voters (March 13, 2016)
2. Applicant: Those who has reported or applied for overseas voting but omitted.
3. How to apply: Attach evidences and send a written form to the Central Election Management Committee or the head of city or town who has the right of registering overseas voters.
 - ※ If a person residing in overseas applies for registering at the nearby diplomatic office, the manager of overseas voting sends a fax to the head of city or town.
